- A) Paul Rogers, Architect, Reported on the Windows Replacement in the Main Building
- B) CSEA Presentation Linda Kenney, President of the CSEA Bargaining Unit of Bridgehampton School District read a statement to the Board acknowledging the vital services performed by the CSEA workers and asked that their work and contributions be respected and rewarded appropriately and that they deserve fair contract.

C) Superintendent's Report – Dr. Youngblood, Superintendent shared several topics:

- Follow-up to a question by the Board President regarding usage of gas from National Grid for the main building over the past three years. This information was to determine whether or not the district has realized any cost savings after the installation of insulation in the roof of the main building.
- Dr. Youngblood informed the Board, continuing her discussion of energy conversation that last summer she attended a meeting hosted by LIPA to investigate electrical cost saving measures that the district could consider implementing. From that meeting she had LIPA conduct an energy survey of the district at no charge, which showed that based upon the current building use, energy consumption, design and age of buildings facility rating is close to our target score. She said the next year, the focus will be on reaching our target score by implementing the energy measures recommended by the LIPA audit. Most of the recommendations focused on improved lighting and controls.
- Next, she reported that she and Mr. Chesterton, Interim Business Administrator had completed a careful screening of the resumes and applications received for the Business Administrator position. The first round of interviews will be scheduled for the week of February 23, 2009.
- The next Edible School Yard Lunch Program Meeting is scheduled for Wednesday, February 11, 2009 at 3:30 PM. She shared that the topic will be on building the Greenhouse.
- Dr. Youngblood informed the Board that she had initiated the accreditation process with the Middle States Association of Colleges and Schools as directed at the January 28, 2009 BOE Workshop. Next, she said she will begin working with various departments to complete the "Candidacy Application".
- Lastly, she shared the Stony Brook University's Southampton Catalog, which had a photograph of our very own 2007 Valedictorian, Yuly Arias, who is doing very well in her academically.
